File review is a great way to look at strengths and weaknesses of the compliance of our IEPs. Much has been learned through the file review process in the 2014-15 school year. This process has always been on a 5 year cycle and has included all 13 districts. KSDE has now chosen to have 3-4 districts in file review each year. This means that the Interlocal will be in file review every year. This process is intensive and requires attention to detail and vigilant support to correct files. Chris Ratzlaff, a current school psychologist for the Interlocal will coordinate the yearly file review process in addition to his school psych assignment.

With the continued lack of state financial support to education, it's a challenge to make the Interlocal budget balance. We have been in deficit spending for several years. This year, the Interlocal's 2014-15 budget ended at a zero deficit! You may wonder how that was possible. The game changer was strong revenues from medicaid billing by our related service staff. Please give these folks a pat on the back!

I'm very proud of our agency! We provide a great service to academic and behaviorally challenged children. We have an outstanding student-centered Board of Education. They understand your work and appreciate you. Our offices and administrative staff will continue to focus on how to best serve you allowing you to accomplish important tasks working with kids and their families!
